CHAIRMAN'S NOTES



Welcome to your Claygate Courier. We are glad to be back. We have spent a lot of time completing a significant upgrade to our website and embarked on social media via Twitter. Many residents have told us how they value the Courier and in this

age of 'instant' communication we now aim to produce the Courier 4 times a year to provide as up to date news and local information as quickly as possible. We thank those volunteers who have helped prepare it in the past, we appreciate all the local organisations who provide material for inclusion and a huge thank you to those volunteers who give up their time to deliver it.

Grant Support to our Local Community

An important responsibility of the Parish Council is the consideration of grant applications. The Parish Council aims to support relevant local services, initiatives and events wherever we can. Recently, we awarded a substantial grant, of £30,000, towards the Claygate Recreation Ground Clubhouse rebuild project (see page 6).

Applications for financial grants, large and small, towards projects initiated by Claygate organisations are always welcome. Full details are available on our website or speak to a Parish Councillor or the Clerk.

Planning and the 40 Acre Green Belt Field

The Parish Council reviews over 200 planning applications in Claygate annually, submitting our comments to the Local Planning Authority, Elmbridge Borough Council (EBC) as well as inputting to planning consultations organised by EBC or the Government.

The Parish Council strives to preserve and protect our Village and its Green Belt. We objected to a planning application for

a Traveller site in Green Belt, which was appealed to the Planning Inspectorate and provided funding towards the cost of independent, professional representation during the planning appeal process. We are very pleased with the decision of the planning inspector to dismiss the appeal, as inappropriate development harmful to the Green Belt (see page 3)

Remembrance Sunday 12th November

Many residents will come together to pay their respects at the Annual Remembrance Day Parade, led by the Scouts and the Outdoor Service at the War Memorial and afterwards at Holy Trinity Church.

Surrey Police no longer provide marshalling for road closures so your Parish Council have partnered with the Scouts and Holy Trinity Church to ensure that the Parade and Outdoor Service continues. The Parish Council has applied for the road closure notice, utilised its public liability insurance for the Parade and Outdoor Service and has paid for trained traffic marshals from a private company approved by Surrey Police. We thank, in advance, those local volunteers who also assist.

Between 10.15am and 11.30 am on the 12th November, stretches of roads in and around the Parade route and War Memorial will be closed, so please take note, as we work together to ensure there is minimum inconvenience.

Notes

*1 The Council released £15,000 of Community Infrastructure Levy Funds (CIL) that it was holding as a restricted reserve, to contribute to the £30,000 grant it agreed, in March 2017, towards the Recreation Ground Trust Clubhouse rebuild. This grant was paid in the 17/18 financial year, so does not appear as Expenditure in 16/17, but the funds were set aside as an earmarked reserve, see also ^{*6}

*2 Overall operating expenses were significantly reduced by 33% versus year ago.

*3 Grant to Claygate Youth Club.

*4 It is Parish Council policy to maintain a general reserve of £15,000 to cover emergencies. Any further general reserve surplus forms a community fund to finance future initiatives and grants.

*5 Does not include any unreleased and restricted CIL funds held by the Parish Council. The Parish Council now receives 15% of CIL, collected by Elmbridge, from development in Claygate that falls within the CIL criteria. These funds can only be spent on certain community infrastructure projects and must be spent within 5 years of receipt. At the end of 16/17 the Parish Council held £1,701 in CIL. Elmbridge holds an additional £6,284 of CIL funds for use in Claygate, payable to the Parish Council when required.

*6 The payments of the grant to the CRGT and for most of the costs of the 40 Acre Planning Inquiry, committed in 16/17, were set aside as earmarked reserves and paid in 17/18.

ENVIRONMENT AND LEISURE

The maintenance and improvement of the Highway Garden Sites is amongst the Parish Council's largest item of expense. These sites around the Village are not owned by the Parish Council but maintained by Elmbridge. Many years ago, CPC entered an agreement to look after them as we believed that they should be maintained to a higher standard than EBC would be willing to or could afford to do. We do receive a grant from EBC towards the cost of maintenance but then spend Parish Council funds on top. The majority of these sites are maintained by a contractor employed by the Parish Council, some jointly with volunteers and a small number solely by volunteers,

We have started to plan a longer term approach to monitoring and maintaining these sites. There are plans for additional planting. Most recently, work has taken place to restore damage to the St. Leonard's Road end of The Green. EBC Street Smart restored the damaged wooden railings and volunteers have undertaken new plantings.

On other matters, after a lot of effort the damaged bus shelter outside the Village Hall has been repaired and the telephone box at the same location has been saved from disconnection



HIGHWAYS AND TRANSPORT

Over recent months the Committee has undertaken maintenance of the horse ride in Woodstock Lane South, further work is planned on the pedestrian footway alongside, to clear more vegetation from the horse ride and to remove fly tipped vegetation.

The committee continues to report defective roads with potholes, missing and damaged

road signs, faulty reinstatements and water leaks. In the case of water leaks we continue to push Thames Water to get them resolved more quickly and permanently.

A key proposal, which we support, in the recent on street parking consultation by SCC, is the control of parking in a short length of Church Road, between Holy Trinity Church and the Recreation Ground, including the entrance to Blakeden Drive, in the hope that this will improve traffic flow and reduce grid-lock at this location.

As the autumn leaves fall and winter approaches, with poor lighting and potentially slippery cycling and driving surfaces we urge motorists to exercise extra caution and cyclists to be safe and utilise helmets, lighting and hi-viz clothing.

PLANNING REPORT

Elmbridge is in the process of updating the Elmbridge Local Plan which sets out the future strategy to meet the need for new homes across the borough. Earlier this year EBC consulted on its strategic option proposals and received a huge number of responses – the vast majority of which opposed any amendment to Green Belt boundaries to meet housing needs.

At the same time the Government published a housing White Paper, 'Fixing our broken housing market' and is now seeking views on a number of proposals to reform the planning system to increase the supply of new homes. To take part go to <https://www.surveymonkey.co.uk/r/planningforhomes>. The deadline is 9th November.

EBC is now reviewing the responses to their consultation in conjunction with the Governments's housing White Paper and aims to come back to residents in early 2018 on how they propose to progress their Local Plan.

We continue to deal with many, varied, Claygate planning applications. The Parish Council Planning Committee meets every 3 weeks. The date, time, agenda of meetings with topline details of all applications under consideration are posted on the two Village noticeboards, one by Boots and the other by the Village Hall, as well as on our website. If a resident wishes to make representation to the committee regarding an application, please contact the Parish Clerk in advance of the meeting to book a time to speak.

40 ACRE FIELD PLANNING APPEAL

Background

The power to grant or refuse planning permission rests with Elmbridge Borough Council (EBC), the Local Planning Authority (LPA). Claygate Parish Council (CPC) reviews and comments on all planning applications in the Village, based on planning policy and passes these comments to EBC. The Parish Council Planning Committee remit states CPC will object to any reduction in the designated Green Belt in and around Claygate and to any proposed development that detracts from its amenity value.

Planning Application for a Traveller Site on the 40 Acre Green Belt Field

The Parish Council objected to planning application (2015/3788), for 8 stables and a barn to include temporary accommodation. This was refused by EBC in February 2016. Thereafter, a retrospective planning application (2016/1567) was submitted for change of use to a Traveller site, incorporating two pitches for siting of 2 mobile homes, a stable/utility room and hard standing, together with provision of a cesspit.

The Parish Council objected on the basis that it was contrary to National and Local Planning Policy and that it provided no very special circumstances to justify such a development in the Green Belt. This application was refused by EBC in October 2016, but the applicants immediately appealed to the Planning Inspectorate.



Fighting the Planning Appeal

Over 1100 objections had been made by Village residents, demonstrating overwhelming concern to protect our Green Belt. Many residents wanted to ensure that EBC actively pursued the dismissal of this appeal.

Consequently, your Parish Council joined with other interested parties in the Village, including the Claygate Village Association (CVA), local residents' associations and other concerned local residents to form the Claygate Community Group (CCG). The CCG sought and was granted 'Rule 6 status' by the Planning Inspectorate, allowing it to be represented at the planning inquiry as a concerned third party to ensure that the views and concerns of the Village were fully heard. The CCG believed that the effect of this appeal, if it was successful, would have a potentially devastating impact on Claygate. The CCG stated to the Planning Inspectorate that it would be able to provide a local community perspective in support of, but over and above that which could be provided by Elmbridge.

Fighting this appeal to defend our Green Belt required an immense effort and a big thank you for the support received across the Village. The CCG employed the services of a Planning Specialist and QC. Such expertise does not come cheaply and the final costs were around £30,000. £15,000 was provided by the Parish Council and the balance came from the CVA, local residents associations and individual resident donations.

Submissions to the Planning Inspector/ Public Inquiry

Individual members of the CCG submitted Statements of Evidence and Affidavits concerning the value that this site and its surroundings (pre-development) enjoyed. These outlined the harm that this application, if approved, would do to the Green Belt, its openness and permanence, the harm to the rural character of the area and the adverse impact on local design and character. It provided evidence concerning the nearby bridleway, as well as the adjacent Local Nature Reserve, Claygate Common and in respect of surface water drainage and flooding.

The public inquiry was planned for 3 days in July. However, when it was opened, the applicants and their representatives did not turn up. The Planning Inspector decided to determine the appeal based on all the written evidence previously supplied by all parties.

The Decision

On September 5th, the independent Planning Inspector, having weighed up the written evidence, dismissed the appeal. Among other comments in the decision (see CPC website for link to full decision) he noted 'The scheme would incur definitional harm through inappropriate development and would impose very significant harm through loss of openness and encroachment'.

The CCG are now engaged in ensuring that Elmbridge Borough Council enforces the decision subject to previously determined timings.



CLAYGATE FLOWER & VILLAGE SHOW

A wonderful time was had by around 5,000 people at the Annual Claygate Flower & Village Show in July, as villagers and visitors kicked up their heels, despite an hour of un-forecast rain at the show's start.

The 104th Annual Show was formally opened by the **Mayor of Elmbridge, Councillor Rachael Lake** with the formal cutting of the doorway sash to the impressive exhibition marquee.

Families enjoyed the wonderful adult and junior exhibits which included flowers, fruit, vegetables, art, photos and domestic delights including cakes, cordials, wine and beer. They also loved participating with their beloved pets in the Companion Dog Show and admiring the vintage cars and motorcycles as well as watching the entertainment in the arena programme, which included local dancers from the **Chadsworth Stage School & Zumba Dancers**, the **1st Claygate Scout and Guide Band**, the **Thames Valley Morris Men** and displays of martial arts by **Kuk Sool Won**.

Barry Fitzpatrick (Chairman) said "Each year we try to get a little better and this year we certainly succeeded. Despite the initial rain a huge crowd arrived at The Show to enjoy a

family afternoon with neighbours and friends. There was a lovely atmosphere as people wandered throughout the show checking out stalls and displays and still found time for some bar or teatime refreshment."

Children of all ages were particularly thrilled with the fun fair, the foot races, the farm animals, exotic animals and the mini rugby try-out, while younger children were all smiles as they participated in the Fancy Dress Parade, had their faces painted, played traditional games and watched Punch and Judy.

Adults enjoyed the tug-of-war, the variety of the Stalls Village, the food and drink and beer tent, primarily provided by the **Ajax Sea Scouts** and new, this year, the Prosecco Tent.

YOUR CENTRE FOR THE COMMUNITY

Claygate Centre for the Community is next to Capelfield GP Surgery in Elm Road. When was the last time you came to see what is on offer, at this wonderful facility?

It was opened 27 years ago, originally as a place for older residents in our community. It is now open to a wider range of residents and offers many activities, services and events. Some are subsidised by Elmbridge Borough Council and others by Friends of Claygate Centre, a charity that supports Claygate Centre for the Community. Some require prior appointment, but all represent good value for money.



ACTIVITIES

These vary from Bingo and Boccia to table tennis and creative activities such as an Art Class. There is a modest fee of £1 for some of these activities. Boccia is a chair based bowls game that all, regardless of physical mobility, can compete in on equal terms. It takes place on Tuesdays and alternate Wednesdays and it is free to participate. Additionally, there is a Bridge Group that meet on Tuesday afternoon and a Wednesday Afternoon Group that provide their own entertainment.

OUTINGS

Day outings are organised by Friends of Claygate Centre. These include trips to seaside locations such as Brighton and Worthing, but also to The Poppy Factory or Buckingham Palace. New ideas are always welcome.

SERVICES

If you want to look and feel better, then you can have a pedicure or manicure or use the hairdressing salon. The hairdressing salon is open daily during the week, whilst the beautician and reflexologist is available once a week. Podiatry is available either through Age UK or privately. All require appointments that can be arranged by contacting the Centre. There are keep fit classes and chair-based exercise suitable for the less mobile. Additionally, you can pick up a bargain from the goods sold at the Centre, these range from greeting cards, wrapping paper and miscellaneous stationery to free range eggs.

EVENTS

Every Thursday entertainment is provided after lunch and throughout the year there are special lunches where entertainment is provided. The Christmas and Easter Fayres are a great opportunity to have fun and grab a bargain. Any profits are used by Friends of Claygate Centre to support the Centre. The Christmas Fayre features a magician/clown, a visit from Father Christmas and stalls that offer a variety of Christmas presents and stocking fillers at bargain prices.

REFRESHMENTS

A three course lunch is available every weekday for £3.90. Good, wholesome freshly cooked food at a great value price. Why not give it a try? Alternatively, if you just want a light snack, there is a Coffee Bar with food and drink including toasted sandwiches, available at discounted prices.

SUPPORT GROUPS

Among the support groups that meet weekly at the Centre are a Parkinson's Support Group (on Monday), a Parkinson's Exercise Group (on Monday) and the Claygate Stroke Support Group (on Friday).

VOLUNTEERING OPPORTUNITIES

Claygate Centre is almost entirely dependent on volunteers to keep things running smoothly. Up to 14 volunteers are needed each day to man the front desk or coffee bar, help serve lunch and organise the meals-on-wheels service. You can spend as little or as much time as you like volunteering at the Centre. Help is particularly required for the weekday meals-on-wheels service. It takes between one and two hours of your time from 11.30 am onwards and is done once a fortnight or more if you can spare the time.

CLAYGATE CENTRE MEMBER/COMMUNITY DISCOUNT CARD

Anyone over the age of 50 is eligible to use the Centre's facilities. There is a modest charge of £12pa (or £20pa for non-Elmbridge residents). You will be provided with a community discount card that not only allows you to use all the services and activities run from all the seven Centres in the Borough, but also entitles you to a discount at select local retailers.

To learn more call the Centre at 01372 463476 or, better still, pop into the Centre and see for yourself. It is open weekdays between 9am and 4.30pm.

WE MADE IT: £190,000 RAISED!



The Project Phoenix Team, with your help and the help of the Community, have put in a 'Gargantuan' effort through

the Summer months and have hit the initial 'Enhancement' project target of £190,000. What a milestone to reach and the target date set by Elmbridge Borough Council made in good time.

Raising £190,000 in six months is no small feat and the trust would like to thank everyone who has been involved in the fundraising effort and everyone who has contributed to the fund.

The request to make improvements to the clubhouse has now been discussed at a Elmbridge Borough Council Cabinet and full council, with a view to commencing demolition and works in March 2018. The build is expected to take eight-and-a-half months. Thank you once again to all that have helped and special thanks must go to the following organisations for their generous support:

Claygate Royals FC, Claygate Cricket Club, Claygate Parish Council, Elmbridge Borough Council, Surrey Police and Crime Commissioner, Surrey Cricket Foundation, Nias Wheatley Charitable Trust, Claygate Village Flower Show, Surrey County Council, Claygate 'Gig on the Rec', Claygate Gardening Society, Claygate Village Women's Institute, Claygate Probud.

The Trust have recently amended the internal plans to provide increased space for the community, both upstairs and downstairs and better flow between the internal and external environment. These amendments are currently being costed out by Kier Construction.
